REQUEST FOR EXPRESSION OF INTEREST (EOI)

1. The Government of Punjab has received a Loan from Asian Development Bank (ADB). Part of the loan's financing will be used for hiring of Center of Excellence Development Firm. The Industries, Commerce, Investment and Skills Development (ICI&SD) Department of Punjab will be the Executing Agency (EA) while the Project Implementation Unit (PIU) - Improving Workforce Readiness in Punjab Project (IWRPP) will be the Implementation Agency (IA). The PIU has already been established which on behalf of the EA will provide guidance on, and oversight to, the overall implementation and performance of the project.

2. The project (IWRPP) will finance the overall establishment of 19 Centers of Excellence (COE) in existing TEVTA & PVTC institutes that will deliver high quality and relevant Technical & Vocational Education and Training (TVET) in the eight priority economic sectors.

The project outputs are described below:

Output 1: Quality and relevance of TVET in priority economic sectors improved.

Output 2: Equitable access to TVET increased.

Output 3: TVET sector institutional framework strengthened.

These consultancy services will be required to lead the gap analysis to identify the training needs, equipment, and resources (international based on best practices) necessary to design and implement high-technology courses and training at COEs; develop an implementation plan for skills development in the priority sectors (ICT & Textile); ensure that the required resources are updated to achieve sustainability and market relevance, as **Skills Training Using High Technology Equipment Firm**.

3. The PIU-IWRPP hereby invites EOI from reputed international firms. The consultants will be recruited using the Biodata Technical Proposal (BTP) procedure based on the **Quality and Cost-Based Selection (QCBS)** method and in accordance with "ADB Procurement Policy on Goods, Works, Non consulting and Consulting Services and Procurement Regulations for ADB Borrowers on Goods, Works, Non consulting and Consulting Services".
